- 2. The quotationer shall have registered as electrical contractor towards Govt. of Maharashtra and shall produce the copy of license
- 3. If quotationer failed to submit the documentary evidence of above work experience then the offer will be liable to treat as Non responsive and 10 % EMD shall be forfeited.
