Post Qualifying Criteria :-

The quotationer should be dealing in line of Power Bucket Sewer Cleaning machine OR choke machine (Sewer line choke removal machine) and shall have supplied spare parts of Power Bucket Sewer Cleaning machine OR choke machine (Sewer line choke removal machine) to any Govt. / Semi Govt. / Municipal body in India in last Seven years. The quotationer shall submit the completion certificate with their offer, failing to which the offer of that quotationer shall be treated as non-responsive.

The spare parts of Power Bucket Sewer Cleaning machine means Screw Jack Assembly, Drum Pulley, M. S. Collar, Clamp Patti, U-Clamp, Thimble. The spare parts of choke machine (Sewer line choke removal machine) means Round Bar Cork Screw of 25 mm / 40 mm / 50 mm, Pickup tool kamatie, Assembly Tool, Push & pull out tool, Point Cutter (Dhabus), G. I. Bend Pipe.

Quotation Document :-

The last date of issue of quotation forms will be up to the day of the due date i.e. 29.09.2022 up to 12.00 noon.

Earnest Money deposit(EMD) :-

The quotationer shall pay E.M.D. of Rs. 5,000/- by way of cash or Demand Draft drawn in favour of Municipal Corporation of Greater Mumbai payable at Mumbai.

The E.M.D. Receipt No. and date shall be clearly mentioned on the envelope.

Only Registered Municipal Suppliers (in case of quotation for supply), having revised Standing Deposit according to their class & category, are exempted from payment of Earnest Money Deposit. However, it is mandatory on the Registered Municipal Suppliers to mention Standing Deposit Receipt No. on the quotation envelope and also enclose attested photo copy of the Standing Deposit Receipt along with the quotation.

The quotation copies shall not be sent or received by post/courier. The Quotations will be opened as stated above, in front of the bidders who wish to attend.

If the office happens to be closed on the date of receipt of the Quotation as specified, the Quotation will be received and opened on the next working day at the same time and venue.
