Pre Qualification Criteria:-

Quotationer shall specifically note following pre qualification criteria towards technical ability.

1. The quotationer should have experience of "Supply Installation Testing and Commissioning/Repairing and overhauling of Screen or dead plate" during last seven (7) years in any Municipal Corporation /Semi Govt. /Govt. & Public Sector Organizations. As documentary evidence 'Performance certificate' shall be produced while purchasing the quotation.

Note: If quotationer failed to submit the documentary evidence of above point will be treated as non responsive and 10 % amount of EMD will be forfeited for Non-responsiveness.

Quotation Document:

The Challan for quotation cost shall be obtained from this office and paid at any CFC Centre. The last date of issue of quotation forms will be up to the day of the due date i.e 20.10.2022 up to 12.00 noon.

Earnest Money Deposit (EMD):

The quotationer shall pay E.M.D. of **Rs. 3000/-** by way of cash or Demand Draft drawn in favour of BRIHANMUMBAI MUNICIPAL CORPORATION payable at Mumbai.
