### **Post Qualifying Criteria :-**

The quotationer should be dealing in line of interior repairs /renovation of offices /commercial establishments and shall have carried out similar type of work at any Govt. / Semi Govt. / Municipal body in India in last Seven years. The quotationer shall submit the completion certificate with their offer, failing to which the offer of that quotationer shall be treated as non-responsive.

Similar type of work shall include repairs / renovation work in offices / chowkies of Govt. / Semi Govt. / Municipal Body.

### **Quotation Document :-**

The blank quotation copies are available in the office of **E.E.Mech.(M.S.)W.S.** at address mentioned below, between 11.00 a.m. to 4.30 p.m. on any working day, except 2nd and 4th Saturday of the month. The Challan for quotation cost shall be obtained from this office and paid at any CFC Centre. A copy of receipt of the payment shall be produced in this office upon which quotation document will be issued. The last date of issue of quotation forms will be up to the day of the due date i.e. 07.11.2022 up to 12.00 noon.

### **Earnest Money deposit(EMD) :-**

The quotationer shall pay E.M.D. of Rs. 3,000/- by way of cash or Demand Draft drawn in favour of Municipal Corporation of Greater Mumbai payable at Mumbai.

The E.M.D. Receipt No. and date shall be clearly mentioned on the envelope.

Only Registered Municipal Suppliers (in case of quotation for supply), having revised Standing Deposit according to their class & category, are exempted from payment of Earnest Money Deposit. However, it is mandatory on the Registered Municipal Suppliers to mention Standing Deposit Receipt No. on the quotation envelope and also enclose attested photo copy of the Standing Deposit Receipt along with the quotation.
