Pre-Qualification Criteria: -

Quotationer shall specifically note following pre-qualification criteria towards technical eligibility:

- 2.The quotationer shall have experience of “Work of Repairing of Pump” during last seven (7) years in any Municipal Corporation /Semi Govt. /Govt. & Public Sector Organizations. He/ She/ They shall submit documents in the evidence of that.

Note: If the quotationer failed to submit the documentary evidence of above point will be treated as non-responsive and 10 % amount of EMD will be forfeited for Non-responsiveness.

Earnest Moneydeposit(EMD):

The quotationer shall pay E.M.D. of Rs.**3,000/-** by way of cash or Demand Draft drawn in favor of BRIHANMUMBAI MUNICIPAL CORPORATION payable at Mumbai.

The E.M.D. Receipt No. and date shall be clearly mentioned on the envelope.

Only Registered Municipal Suppliers (In case of supply only), having revised Standing Deposit according to their class & category, are exempted from payment of Earnest Money Deposit. However, it is mandatory on the Registered Municipal Suppliers to mention Standing Deposit Receipt No. on the quotation envelope and also enclose attested photo copy of the Standing Deposit Receipt along with the quotation.
