### **Pre Qualification Criteria:-**

The quotationer should have experience of “Work of anti corrosive painting to EOT Cranes” during last seven (7) years in any Municipal Corporation /Semi Govt. /Govt. & Public Sector Organizations. As documentary evidence ‘Performance certificate’ shall be produced while purchasing the quotation.

**Note:** If quotationer failed to submit the documentary evidence of above, the quotationer will be treated as non responsive and 10 % amount of EMD will be forfeited for Non-responsiveness.
