


FOREWORD

The Municipal Corporation of Greater Bombay is an autonomous Body, established under the provisions of Bombay Municipal Corporation Act, 1888 to administer the civic affairs of the Bombay City. The Municipal Commissioner is the Chief Executive Head of this Body and is responsible for providing and maintaining civic services in the city.

As per the provisions of Bombay Town Planning Act, 1954, it was necessary for the Municipal Corporation to prepare a Development Plan for Greater Bombay area. Such a plan was, therefore, prepared which came into force in 1967. This Development Plan however, was not effective as it did not involve any public participation and relied entirely on the Municipal Corporation to generate resources to meet the cost of acquisition of land, removal of encumbrances and development of the amenities. Moreover, there was no specific provisions available to raise the funds solely for the purpose of implementation of the Development Plan.

Keeping in view of the weaknesses of the First Development Plan, the Municipal Corporation has now revised the said Development Plan. The Revised Development Plan has already come into force and is effective upto year 2001. This plan involves public participation and there are such provisions in the said Development Plan and the Development Control Regulations, 1991, sanctioned alongwith the said plan that it would be possible now for the Municipal Corporation to implement the said plan without such financial liability.


It is felt that the citizens should be made aware of the broad outline of the Development Plan and the Development Control Regulations, 1991, so that they would be able to understand and participate more effectively in the implementation of the said Development Plan.

For the sake of convenience and to make it more effective it is proposed to prepare a booklet 'Know Your Ward Development Plan' for each Municipal Administrative Ward and print it for the benefit of general public.

We have great pleasure to publish the booklet in this series titled 'Know Your Development Plan for K/West Ward'. We are sure that it will help citizen to understand the basic characteristics of 'K/West Ward', the amenities already existing in the Ward and the amenities proposed to be developed in the Revised sanctioned Development Plan. It is hoped that the citizens would make full use of this booklet and help the Municipal Corporation in implementing the Development Plan for betterment of this great metropolis.

KNOW YOUR WARD

K/WEST WARD DEVELOPMENT PLAN


BACKGROUND:

Three and half centuries ago, Bombay was a group of seven tiny islands predominantly inhabited by Kolis and the main trades were fishing, agriculture and coconut plantation etc. In 1667, these island were taken on lease by the East India Company for the purpose of trade and commerce. They established a port, being the most suitable location and the same was constructed where the Gateway of India

stands today. This started the development of Bombay City, which has now grown into metropolis.

Earlier the limit of Municipal Corporation was confined to City area only. The Suburban areas which are now comprised of L, M, N, H and K wards were merged and brought within the jurisdiction of the Corporation in the year 1950, wereas the extended suburb areas comprising of 'S', 'T', 'P' & 'R' Wards were merged within the Corporation limit in the year 1957. With the passage of time with all around development, the area within the

jurisdiction of the Corporation now called as Greater Bombay, has grown into the great metropolis with the population of around 1 crore.

The City has been divided into administrative wards for the purpose of local administration. K/Ward admeasure 23.29 sq. kms. in area. It is bounded by Arabian Sea on West side, Western Railway on East side, Oshiwara Bridge/Nalla on North side and Milan Subway on South side. It is accessible from Western Railway's Vileparle, Andheri & Jogeshwari station directly. As per the census of 1991, the population of K/West Ward is 5,47,121.

2. CHARACTERISTICS:

The area of K/West Ward was added in 1950 to the Greater Bombay and as such, development is of mixed type i.e. there are Gaothans and Koliwadas existing like Versova, Juhu, Ambivli etc. as also, there are newly constructed multi-storeyed buildings. This Ward has become a prime residential locality over the years. Since most of the area is in Residential Zone. there are no major administrative offices of Central Government or State Government. However, the Fisheries Institute of the Government of India, aerated lagoons (part of sewerage project) are situated in this Ward.


The Ward contains the oldest Gaothans and Koliwadas, like Juhu Koliwada, Versova Koliwada, Madh Koliwada and Ambivali & Bandivali Gaothans. The development in this area is very old, and structure are mostly ground plus one storey. The residents are the native people having business mainly connected with fishing industries.

The Ward contains the longest coastal beach from Juhu Koliwada upto Versova having a length of @ 8 kms. which is practically unencumbered. The famous Juhu beach is the part of the coastal beach and one of the tourist attraction. There are many starred hotels, developed along this coastal beach considering the tourist inflow. Predominantly, many residential developments are also taking place alongwith coastal beach on the lands, which are mostly Government lands.

This ward has the only Flying Club of Bombay popularly known as Juhu Flying Club. This is the first airport in India where the first flight was landed by Late Sir J.R.D. Tata in 1928. This Ward has the famouns institutes of education like S.N.D.T. University, the Bhavan's education complex which includes the Sardar Patel Engineering College, B.M.' Poly-technique, N.M. & Mithibai College etc.

The predominant features of the Ward are as under:

 District Commercial Centres at Oshiwara and Bandivali, where the BMRDA has been appoited as a Planning Authority.

- 2. The MHADA's layouts at Oshiwara and Versova villages.
- 3. The Collector's layout at Versova village.
- This Ward has longest coastal beach as explained earlier and many starred hotels have come up along side.
- 5. Shahaji Raje Sports
 Complex has been constructed at J.P. Road,
 Andheri (West) to satisfy the needs of the Western Suburbs for the sports activities.
- 6. The biggest public hospital known as Cooper Hospital is situated in this Ward and it is also served by the technically advanced private Hospital such as Nanavati Hospital.
- 7. The J.V.P.D. Scheme which is very posh locality and predominatly residential in nature.
- 8. The Wireless Station near Chandan Cinema.
- The Bhavan's educational complex which includes the Sardar Patel Engineering College.
- 10. S.N.D.T. University.

The K/West Ward is served with net work of roads, which includes 5 major roads as under:

- 1. Swami Vivekanand Road
- 2. Jai Prakash Road
- 3. Vaikunthlal Mehta Road
- 4. Andheri-Oshiwara Link Road
- 5. Juhu Road.

The K/West Ward is centrally located in the Western Suburbs and as such, provides a link between Southern Bombay and Northern Bombay through the major link roads, like S.V. Road, Juhu Road, North-South Link Road etc.


Considering the heavy vehicular traffic, being a predominatly higher class

residential area, the J.P. Road and 10th Road in Vile Parle are already concretized, whereas remaining link roads are being concretized stagewise.

DEVELOPMENT PLAN - 1967

As per the provisions of the Bombay Town Planning Act 1954, the development plan of Greater Bombay was first prepared by the Muncipal Corporation for the areas within their Jurisdiction. The development plans of various wards were sanctioned in the year 1967. The development plan includes zoning for Residential, Commercial, Industrial and No Development Zone. It also includes reservations for various public amenities and utilities. However, number of

reservations proposed were less. It also included a proper net-work of proposed roads.

3.1. Due to financial stringency and various other constraints, the development plan of 1967 could be implemented to a very small extent by the Municipal Corporation. As a result, only very few reservations could be developed in this Ward.

REVISED DEVELOPMENT PLAN - 1991.

After sanctioning of the early development plan, there were number of changes in policies, which were taken into account while preparing the development plan. Further in the

meantime, the M.R. & T.P. Act came into force replacing Bombay Town Planning Act, 1954, which also provides for appointment of a Regional Authority. The Government, therefore, appointed Bombay Metropolitan Regional Development Authority to look after the development of various areas surrounding Bombay and also lay down policies and guide-lines for development within City of Bombay.

- 4.1. The State Government has also sanctioned the Development Control Regulations, 1991 and the same have come into effect from 25.3.1991.
- **4.2.** The list of existing amenities and sites reserved for proposed amenities

in K/West Ward is given in Appendix I. This is a summary statement, which includes the number of existing and proposed amenities and the corresponding area in sq. mts. Further, the entire K/West Ward is having 17.58 sq. km. 0.6727 sq. km., 1.158 sq. km., 3.87 Sq. km. of area in Residential, Commercial, Industrial and "No Development Zone" respectively.

5. IMPLEMENTATION OF REVISED DEVELOPMENT PLAN:

The revised Development Plan is for a period of 20 years from 1981 to 2001. Due to several difficulties, the plan came to be sanctioned only in 1993. As such, a short time is available for implementation. It will be, therefore, necessary for the Municipal Corporation to prepare a phase-wise programe to develop the amenities shown in the Development Plan within the planned period.

6. MECHANISM FOR DEVELOPMENT:

The proposed amenities can be developed in the following manner.

6.1. The Municipal Corporation can acquire the plot under the provisions of the M.R. & T.P. Act, remove the

encumbrances thereon by rehabilitating the authorised occupants elsewhere and developing the amenity as per the requirement of the local population. The Corporation has to incur the cost of acquisition, rehabilitation and development. This was the basic principle adopted for implementation of the Development Plan sanctioned in 1967. As the Municipal Corporation could not provide adequate financial resources. the amenities could not be developed to the desired extent. In order to facilitate, specific provisions have been made in D.C. Regulations, which will speed up the development of such reserved sites for the specific purposes without incurring any expenditure by the Corporation and will minimize acquisition procedure which is costly and time consuming.

Under Regulation No. 9, a list of 6.2. public amenities has been given, which can be developed by the owner and haded over to the Municipal Corporation or other Appropriate Authority as the case may be, free of cost. The owner can then develop the plot for the permissible users in the zone, to its fullest extent (treating the amenity free of F.S.I.). Thus, the Municipal Corporation or the Appropriate Authority will get the constructed amenity without incurring any expenditure. The said regulation also provides for the Municipal Corporation to hand over the constructed amenity to any registered institution or trust for operation and maintenance. Due to this regulation. many reservations such as Shopping Centre, Maternity Home, Municipal Chowky, General Hospital, Library etc. will be available to Corporation for benefit of public at large.

An important provision has been made under the D.C. Regulation No. 34 for grant of "Transferable Development Rights" (TDR). Under this provision, if the owner removes the encumbrances on the plot under reservation, levels the plot under reference, puts a compound wall with a gate and hands it to the Corporation or the State Government as the case may be, free of cost, he is entitled to get the development rights in the form of full F.S.I. of the plot handed over, to be used elsewhere. For the purpose of utilization of the transferrable F.S.I., the Greater Bombay area is divided into 2 zones i.e. Receiving Zone and Non-Receiving Zone. As such, transferable F.S.I., can be used only in the Receiving Zone. The entire city and the area between the S.V. Road and Western Express Highway in the Western Suburbs and area between L.B.S. Marg and Central Railway Main Line in the Eastern Suburbs have been placed in the Non-receiving Zone. The transferrable F.S.I., therefore, will not be allowed to be used in these areas. This provision will enable the Municipal Corporation/State Government to take over plots free of cost, for which the benefit of D.C. Regulation No. 9, (accommodation reservation) is not available.

6.3.1. The D.C. Regulation No. 34 also allows the owner to hand over the plot as specified above alongwith the constructed amenity thereat, as per the requirements of the concerned authority. Under such circumstances, the owner is entitled to have further additional F.S.I. (Transferable) equivalent to the built up area of the amenity constructed. This Regulation No. 34 not only provides for taking over the reserved plot free of cost but also enables the concerned authority to get the amenity constructed thereon, free of cost.

6.3.2. As far as K/West Ward is concerned, the land cost has escalated in consonance with the general escalation of land cost in Greater Bombay. Therefore, the provision of T.D.R. generating from this area toward Northern side, etc. will not be very attractive. However, since the amenity reserved for Ward are likely to be cleared and the F.S.I. can be utilized within the Ward, there is likelihood of such amenities coming into Municipal possession in lieu of grant of T.D.R. Moreover, quite a much area of this Ward is in receivable zone for T.D.R. and as such, T.D.R. generated from the Island City of 'H' & 'M' Wards is likely to be utilized on these lands. Considering this, the residential development in this locality is bound to get a boost in coming vear.

6.4. As regards the sites reserved for Public Housing/High Density Housing, the D.C. Regulation No. 9 allows this reservations to be developed by the

owner, subject to certain conditions. The most important condition being that 10% of the tenements of 180 sq.ft. carpet area be handed over to the Municipal Corporation for accommodating the Project affected people, who are required to be shifted due to the development of reservations, including widening of roads etc. The owner however, is entitled to get the construction cost of each tenement plus 15% profit thereon. Public Housing reservations in the Ward could be developed by taking advantage of this provision.

6.5 Few areas in this Ward is situated in an Industrial Zone. However, in view of the provisions of the D.C. Regulation No. 56/57, this land can be allowed to be developed for commercial/residential purposes. As such, the industrial activity may receive stangnation and commercial/residential development in this Ward is likely to get impetus.

7. AUTHORITIES RESPONSIBLE FOR IMPLEMENTATION:

Since the revised Development Plan is required to be implemented within a span of years, it is necessary that the proper phase-wise programme is prepared taking into consideration the priorities of the local population. It is, therefore, advisable that the entire Ward is divided into suitable sectors and the priorities are fixed for development of amenities therein. Based on these sectorwise priorities, a final priority list for the entire Ward can be prepared. Since the preparation of priority list is

- directly related to the local needs, the W.Os/Zonal D.M.Cs should prepare such a priority list in consultation with sectional heads in the Ward and the local Councillors, elected representatives and local community.
 - 7.1. The Office of the Ch. Engineer (Development Plan) will prepare yearwise priority list for availing T.D.R. and publish the same for the benefit of owners of the reserved plots (such publication of yearly priority list of availing T.D.R. is obligatory under the provision of D.C. Regulation No. 34).
 - 7.2. It will also be necessary to take timely steps to develop the plots made available under the T.D.R. facility or to put to use the constructed amenity either under T.D.R. facility or under accommodation reservation. The Zonal D.M.C., W.O. and the Local Councillors will have to take a lead and play a constructive role in fuller implementation of the Development Plan of the Ward thereby making available amenities and facilities to residence of the locality.
